2021 STALLION SERVICE CONTRACT - CHILLED/FROZEN SEMEN

	THIS AGREEMENT is made and entered on the
1.	Mare owner hereby agrees to breed their mare
	A service fee of \$1650.00 (inclusive of GST) is agreed upon to be paid when the mare is pronounced safe in foal (45 day scan). No bookin fee required. The mare will not be released to the owner until such a time as all veterinary expenses, agistment bills and any other charges incurred on behalf of the mare have been paid to the relevant parties in full. No service Certificate will be issued until accounts are paid in full. A Further \$200 fee will incur at the use of stored frozen semen. A copy of mare's registration papers must accompany this contract. Stallion Owner will provide AQHA breed certificates for all eligible mares. Any mare owner wishing to seek registration with other breed societies must purchase and provide the relevant breed certificate to the stallion owner for completion.
2.	All RBH Fully Loaded semen remains the property of the stallion owner, and may not be collected, stored, distributed or sold by any other party. The service fee of \$1650 (inc GST) entitles the payee to the genetics of RBH Fully Loaded and a live foal guarantee on one foal onl This amount is payable by the person/entity named in this agreement to the stallion owner on each and every foal created by RBH Fully Loaded semen. When attempting embryo transfer and two eggs are flushed, any additional embryo/foal will be invoiced to the mare owner on a positive pregnancy test. All shipped semen collection costs are seperate from this contract and payable by the mare owner. The stallion owner will not be held responsible for semen lost in transit.
3.	This contract offers live foal guarantee for one foal. However, after 3 attempts at service, if after consultation with the mare owner, vet an stallion owner, a change of mare may be requested by the stallion owner with no additional charges payable for the service fee by the mar owner.
4.	The live foal guarantee become null and void if the mare owner returns the mare to work/competition after a positive pregnancy test.
5.	All mares must be tractable and handled to lead. The stallion owner reserves the right to refuse any mare for service.
6.	It is further agreed that should a stallion die or become unfit for service, and frozen semen becomes unavailable to fulfil rebreed commitments as per condition 9, then this contract shall become null and void, and any money paid as part of the service fee shall be refunded less any veterinary and agistment fees.
7.	Mare owner agrees the stallion owner will not be responsible for any disease, accident, sickness, or death to mare owners mare or foal, and that breeding farm will exercise their judgement in supervising and caring for mares. Mare owner will likewise not be responsible for any disease, accident, sickness or death to stallion or mare.
8.	Mare owner agrees to have the stallion owners veterinarian check the mare owners mare for normal breeding condition, and to perform such other veterinary services that stallion owner deems necessary, at the mare owners expense. This includes worming, treating infections, preventative measures, original examination, pregnancy checking, treatment of any illness/injury, etc.
9.	In the event that the mare aborts or if the foal does not stand to nurse, it is agreed that the mare owner may return the mare for breeding during the following breeding season and no stud fee will be charged for subsequent breeding. To be entitled to such subsequent breeding the mare owner must deliver to the stallion owner a certificate by a licensed veterinarian attesting that the mare aborted or that the foal failed to stand and nurse, accompanied by Stallion Service Certificate and such delivery shall be made within ten (10) days of the date that the mare aborts or the foal is born. Any mare owner who chooses to not take their rebreed in the following season will lose live foal guarantee unless prior approval granted by stallion owner.
10.	It is agreed that all sums payable to the stallion owner will be paid as per terms of the Tax Invoice issued. When mare owner signs and returns one copy of this contract with payment of the booking fee to the stallion owner, it will be a binding contract on both parties subject to the above terms and conditions. This contract is not transferable or assignable.
